

ARDGOWAN SCHOOL (#3704)

Enrolment Scheme Description

Effective from 28 January 2019

The guidelines for development and operation of enrolment schemes are issued under section 11G (3) of the Education Act 1989 for the purpose of describing the basis on which the Secretary's powers in relation to enrolment schemes will be exercised.

Home Zone

All students who live within the home zone described below (and shown on the attached map) shall be eligible to enrol at the school.

The enrolment scheme home zone takes addresses bounded by and on both sides of the boundary roads mentioned in the description unless otherwise stated.

Starting from the intersection of Redcastle Road and Reservoir Road the home zone follows;

- North-west on Redcastle Road until Ardgowan Road
- North on Ardgowan Road until Eden Road (including Ardgowan Road to the north of Eden Road)
- North-west on Eden Road until its intersection with Oamaru Creek Road and Devils Bridge Road (including Rosebery Road)
- South on Devils Bridge Road until Homestead Road (including up to 143 Oamaru Creek Road and Turfus Camp Road)
- East on Homestead Road until Ardgowan Road (including Homestead Road west of Devils Bridge Road until Parsons Road)
- South on Ardgowan Road until number 31 Ardgowan Road (38 on the eastern side of the road)
- From number 38 Ardgowan Road follows the property boundary of 38 Ardgowan Road and then jumps south to the southern end of Reservoir Road
- From the end of Reservoir Road travels north-east on Reservoir Road until Redcastle Road (including Bedford Street, North Ridge Drive, and Macs Ridge Road)
- South-east on Redcastle Road until but not including number 74 Redcastle Road

Special Programmes

This priority category is not applicable at this school because the school does not run a Special programme approved by the Secretary.

Out of Zone Enrolments

Each year the Board of Trustees will determine the number of places which are likely to be available in the following year for the enrolment of students who live outside the home zone. The Board will publish this information by notice in a daily or community newspaper circulating in the area served by the school. The notice will indicate how applications are to be made and will specify a date by which all applications must be received.

Applications for enrolments will be processed in the following order of priority:

- First Priority This priority is not applicable at this school because the school does not run a special programme approved by the Secretary for Education.
- Second Priority will be given to applicants who are siblings of current students.
- Third Priority will be given to applicants who are siblings of former students.
- Fourth Priority will be given to any applicant who is a child of a former student of the school.
- Fifth Priority will be given to any applicant who is either a child of an employee of the board of the school or a child of a member of the board of the school.
- Sixth Priority will be given to all other applicants.

If there are more applicants in the second, third, fourth, fifth or sixth priority groups than there are places available, Selection within the priority group will be by ballot conducted in accordance with instructions by the Secretary. Under Section 11G (1) on the Education Act 1989. Parents will be informed of the date of any ballot by notice in a daily or community newspaper circulating in the area served by the school.

Applicants seeking second or third priority status may be required to give proof of a sibling relationship.
